MARATHON REGULATIONS

1 - ORGANIZATION

The WE ARE RUNNING OUT OF TIME Marathon is a project of ilhas estúdio for the Walk&Talk Festival of the Azores. It is a joint organisation by ilhas estúdio, Walk&Talk, Endurance Sports Company and Diogo Caetano from the Friends of the Azores, with the support and involvement of the Government of Portugal, the Government of the Azores, Garantir Cultura, the Municipality of Ponta Delgada and the Parish Council of Relva. In addition to these institutions it has the collaboration of the following associations: Soliedaried'arte Açores, Cresaçor - Cooperativa Regional de Economia Solidária, AMAR - Açores Pela Diversidade, APF - Associação de Planeamento Familiar, Pride Açores, APAV - Apoio à Vítima, AIPA - Associação Dos Imigrantes Nos Açores, Amigos dos Açores, Kairós - Cooperativa Incubação Iniciativas Economia Solidária, Novas Rotas, A Alternativa - Associação Contra as Dependências, Arrisca, Novo Dia - Associação para a Inclusão Social, As Cores dos Açores e Aurora Social.

2 - EVENT

It will be composed of four courses:

- > 42,4 km, for participants over 18 years old;
- > 22,4 km, for participants over 18 years
- > 7 km, for participants over 16 years old;
- > 3 km, for all age groups and without competitive purposes.

*Only those who are duly registered will be able to participate.

3 - DATE AND TIME OF THE COMPETITION

The WE ARE RUNNING OUT OF TIME Marathon takes place on 24 July 2021, and the start times are as follows:

- 9h00 - 42.4 km
- 11h00 - 22.4 km
- 12h00 - 7 km
- 14h00 - 3 km

4 - DURATION

All the races have an arrival time limit until 17h00, regardless of the departure time.

- 42,4 km Course - maximum 8 hours
- 22,4 km Course - maximum 6 hours
- 7 km Course - maximum 4'30 hours
- 3 km Course - maximum 3 hours

The organization will control the pace of the walk. After the passage of the race vehicle, participants who are on the course and wish to continue, will be under their own responsibility and will have to obey the traffic rules of the Portuguese Highway Code.

5 - REGISTRATION

The data entered at registration is the sole responsibility of the user who will be fully responsible for its accuracy, truthfulness and authenticity of the data.

Entries are only confirmed after payment. You can get the proof of registration in the user area on the registration platform My Azores Trail Run <https://myazorestailrun.com>

5.1 - Payment must be made before the deadline indicated in the registration platform. After this deadline, registrations will not be accepted. If payment is not made before the established deadline, you must reopen the registration on the platform and generate new payment references with price and registration conditions at the time.

5.2 - If you pay after the date indicated in the payment instructions of the registration platform, your registration will be cancelled. You will have up to 30 days after registration to request a refund by emailing info@walktalkazores.org. A processing fee and commission for this service will be charged, amounting to 10€.

5.2.1 - Any change in the registration data will have an associated cost of 3€ and is only possible until 15 July 2021.

The transfer or sale of bib numbers/registrations to third parties is not authorised. The organisation will prevent registration in future events of people who proceed in this way, through the identification of the badge used by third parties.

5.3 The organisation may at any time suspend or extend deadlines, or add or limit the number of entries for the event due to technical/structural needs/availability without prior notice.

5.4 The data used for the classifications are those supplied at the time of registration.

IMPORTANT: The participant expressly consents that their data be ceded to the insurance company responsible for carrying out the compulsory accident and civil liability insurance as well as the disclosure of the classifications of the different races of the event.

6 - REGISTRATION FEES

Course 42,4 km: 20€

Course 22,4 km: 15€

Course 7 km: 10€

Course 3 km: 5€

By registering, the athlete is implicitly agreeing in full with the present regulation. Each registration is personal and non-transferable.

7 - BIB NUMBER PICK UP

To collect the bib number, the participant must carry the proof of registration and / or identification document with photo.

The bib number can be picked up on the July 23rd, at vaga - espaço de arte e conhecimento, located at Travessa das Laranjeiras 51, Ponta Delgada. Presentation of proof of registration with dorsal number, on paper or digital format is mandatory.

If the participant cannot collect their bib number in person, a third party may collect it for them, in the condition that he/she presents the participant's original proof of registration, always accompanied by a copy of the participant's ID card.

8 - CATEGORIES

Courses 42,4 km, 22,4 km and 7 km:

Senior: Athletes born in 2001 or before.

The class is considered based on the exact age verified in the year of the race.

For a class to be constituted, at least three participants of the same sex must be present at the starting line. The participants of the classes that are not constituted will be integrated in the class immediately before theirs.

3 km Course:

Without Classes

9 - SUPPLIES

Marked on the map on the race website.

10 - ASSISTANCE

Medical teams, together with specialized ambulances, will be present. to give first aid or medical assistance as possible and necessary. Continuity of the medical assistance, if necessary, will be done by the regional health service.

The organization is obliged to sign the sports insurance contract required by law, valid and in favour of all registered non federated participants. In case the participant is admitted in a Regional Health Service Institution, the organisation must be informed as soon as possible in order to activate the insurance, incurring the risk of the process not being accepted if this notification is not made in due time. The payment of the moderator fees is the responsibility of the participant, and may be reimbursed by the insurance company if the process meets the necessary requirements.

Law enforcement agents will be present in order to regulate the participants and the traffic of people and vehicles throughout the duration of the race. Volunteers and members of the organization will also be present. Participants are required to comply with their instructions.

11 - SERVICES

11.1- SHOWERS

Due to the pandemic situation, due to COVID-19, showers will not be available at the end of the race.

12 - CLASSIFICATIONS

42,4 km, 22,4 km and 7 km courses:

The classifications will be presented on the event website, and may be changed if any inconsistencies are found.

3 Km course:

There will be no individual or team classification.

13 - TIMING

The course is timed with an electronic system - “chip”. In order for the chip to be read, the athlete must wear the bib number (which contains the chip) clearly visible on the front (chest area) during the entire race, in perfect state of conservation. All the participants in the 42,4 km, 22,4 km and 7 km courses will have to use the chip provided, which is personal and non-transferable. The organisation is not responsible for the failure in the presentation of results resulting from the incorrect placement of the chip. Any participant who uses another athlete’s chip, more than one chip or does not have it at one of the intermediate controls will be disqualified. The 3 km course will not be timed.

14 - PRIZES

The Marathon has 54 prizes in total, consisting of numbered and signed silkscreens. 42,4 km, 22,4 km, 7 km routes has 3 prizes, for the three genders taking part: female, male and non-binary. Likewise, for athletes with disabilities. The 3 km route doesn't have prizes, since it is not being timed.

15 - INFRACTION

Athletes will be subject to sanctions/disqualification if they:

- Do not make the start control;
- Do not pass the compulsory control points;
- Do not complete the course in its entirety;
- Do not wear the bib number clearly visible during the course;
- Falsify any element related to their registration;
- Run with a bib number that does not correspond to the name on the inscription;
- Do not respect the rules of traffic and good conduct;
- Intentionally harm their opponents;
- Refuse to help another participant in obvious difficulties;
- Have any unsportsmanlike conduct;
- Leave rubbish on the track or disrespect the environment;
- Ignore the instructions of members of the organisation.

16 - COMPLAINTS

Any complaint or protest must be presented in writing, compulsorily, to the course jury, at Complexo Desportivo da Relva, until 30 minutes after the results are known.

17 - REGULATION / PERSONAL DATA / RESPONSIBILITY

The participant, by confirming his registration, declares to recognise and accept the present regulation, the data protection and disclaimer text. In case of doubt, the decision of the organisation will prevail.

18 - DISCLAIMER OF RESPONSIBILITY AND PROTECTION

By registering, the participant declares the following: "I am in good health to participate in the We are Running out of Time Marathon, in Walk&Talk - Arts Festival. I exclude all responsibility from the organisation and sponsors or other participating institutions for any accident or injury that I might suffer before, during and/or after the sporting event, renouncing any legal action against any of the mentioned entities. During the course of the competition, I will contribute as much as possible with the Organisation to avoid personal accidents.

I also authorise the Organisation to make publicity use of the photos, videos and any other type of audiovisual material in which I may appear, accepting the publication of my name in the classification of the race, in the media and/or internet, without expecting any payment, compensation or retribution for this object".

The organisation recommends that all participants have a medical assessment before the event. All participants accept the risk arising from the sporting activity.

All participants consent to the free and unconditional cession of the rights of use of their personal data for marketing purposes, and of their image captured in the official filming and photographs that will take place during the events, consenting to its reproduction in the media of the organisation itself or of third parties.

19 - CANCELLATION OR POSTPONEMENT OF THE EVENT

The cancellation of the event may occur due to factors external to the organisation: natural disasters, strikes, demonstrations, pandemics, impossibility of using the traffic circulation routes, impossibility of using telecommunications, government restrictions or new legislation. In these cases, the organisation reserves the right, within 30 days of the event's scheduled date, to issue an opinion about the actions to be taken resulting from the seriousness of the cancellation and to proceed with the partial reimbursement of the participation to each of the athletes.

20 - REGULATIONS

Any cases omitted in the present regulations will be solved according to the opinion of the organisation.
